1. Introduction

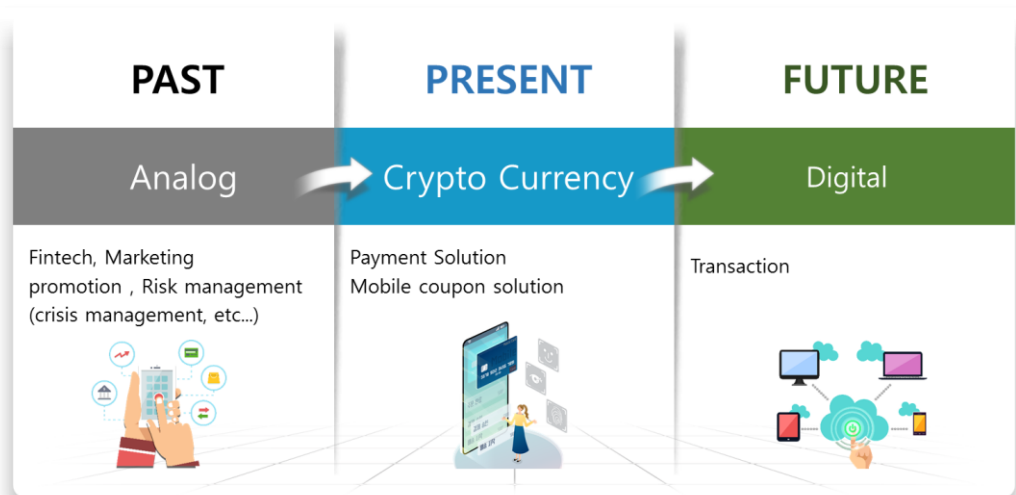
1.1 GP Token

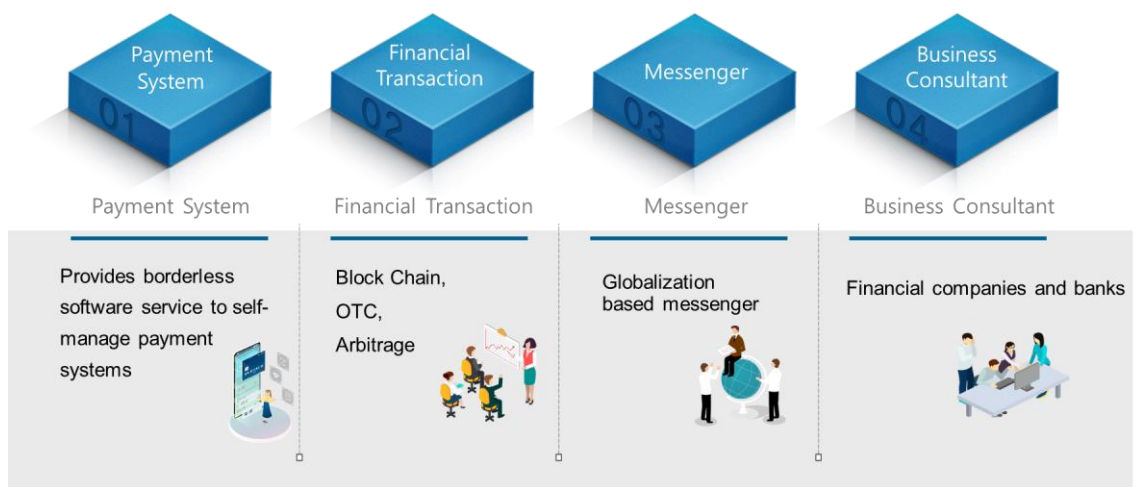

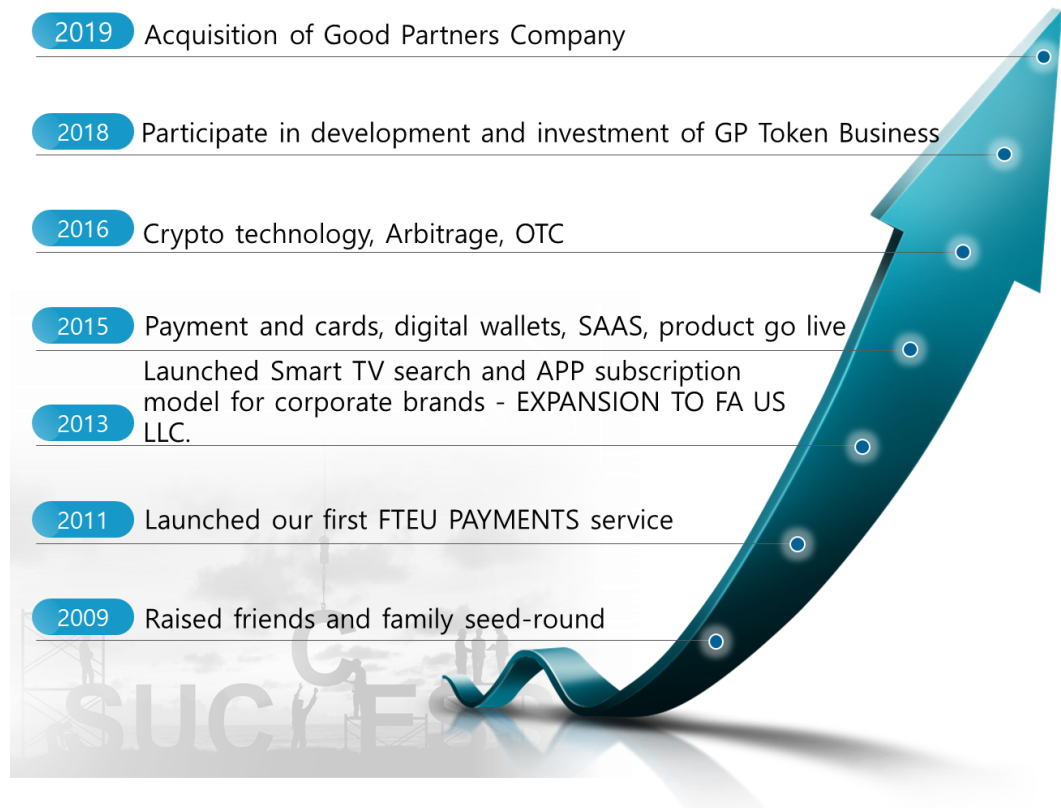


1.2 Background

1.3 Specific

GP Token is based on the EOS platform and DPoS Algorithm. EOS utilizes the decentralized consensus algorithm which proves capable of meeting the performance requirements of applications on the blockchain, Delegated Proof of Stake (DPOS). The DPOS of EOS is a step further than Ehtereum's PoS. By distinguishing the roles of the nodes, the nodes of EOS are quick to negotiate. As a result, transaction processing speed has also become faster. Block creation speed and modification speed are also improved. GP Token proves both its stability against external attacks and its processing speed for its participants through its own algorithm. In addition, Windows, Android, and ISO have been applied to the form of the wallet, thereby improving the usability and the convenience of users.

2. Business Model

2.1 Platform

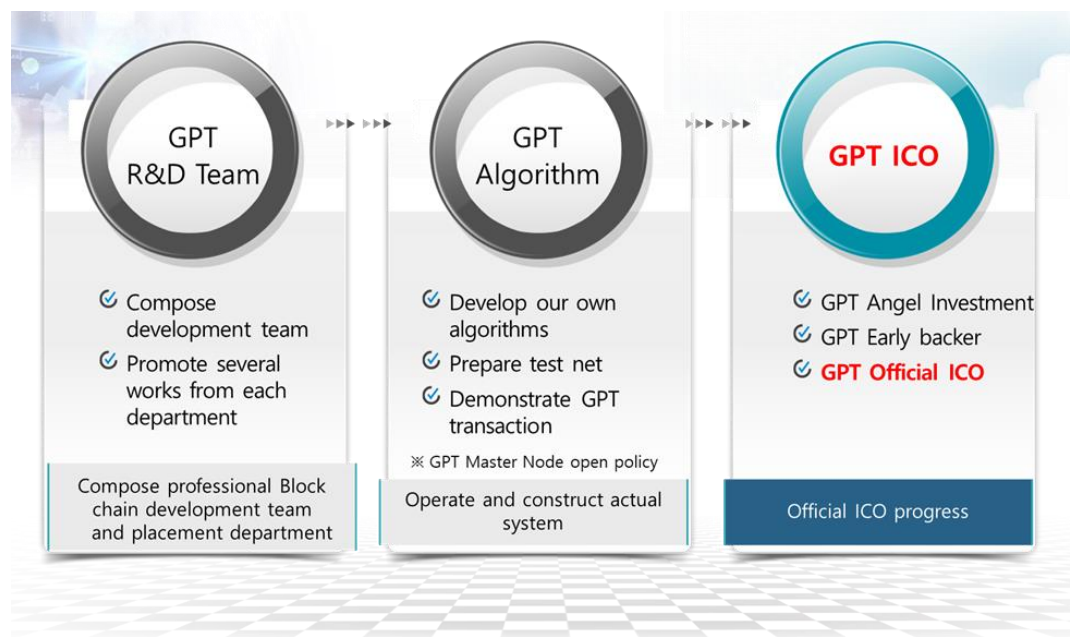
GP Token's platform provides an integrated solution that ensures maximum transaction efficiency. Therefore, users can get the maximum benefit without being affected by the coin market.

GP Token has constructed strategically designed ABT, ESC and CBR solutions within the platform. And GP Token's platform was released through ICO. With GP Token's platform, users can benefit from using GPT Pay and Mobile Coupon.



2.2 ICO

GP Token formally launched ICO to secure retail investors and pro supporters. GP Token's successful ICO is based on its own technology and advance preparation. GP Token has been working on securing its own technology by developing R&D Team and specializing in GP Token's block-chain technology and algorithm. In addition, GP Token's block-chain algorithm has been pre-tested through actual demonstrations.



2.3 Master Node Policy

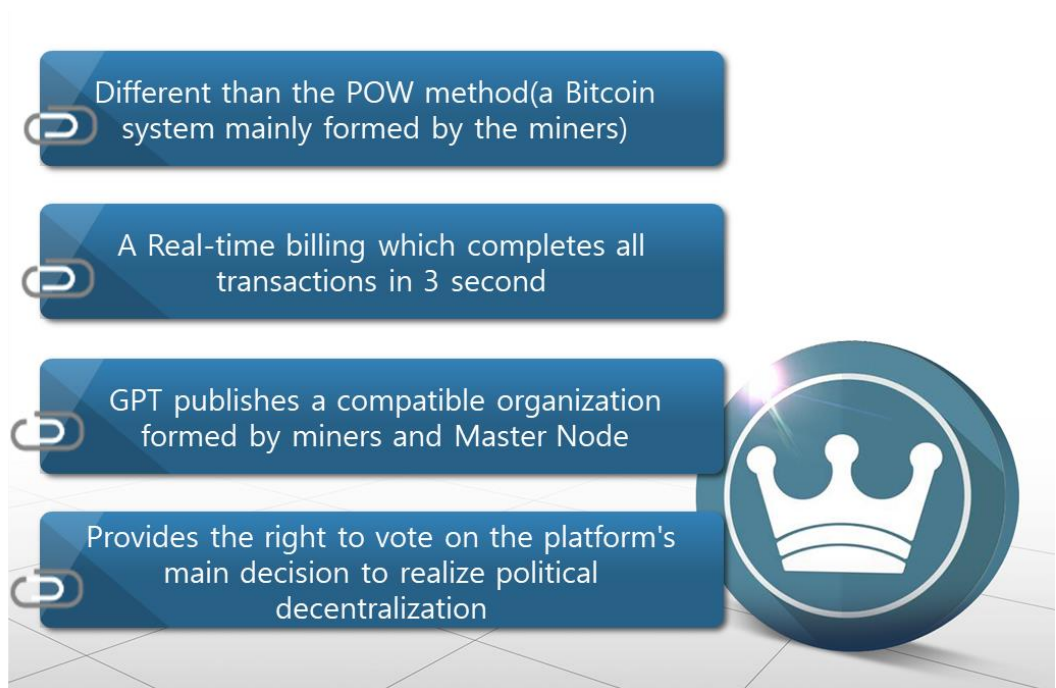
The master node of GP Token is given to service participants who satisfy certain conditions. The master node is associated with data mining systems that include GP Token's solution as well as traditional CPU or ASIC equipment. GP Token's platform will assign the master node a participant who occupies a node in excess of the standard quantity on the service system, and will strengthen the system's authority.



First, data mining users do not have to manually configure and supplement their systems like Bitcoin.

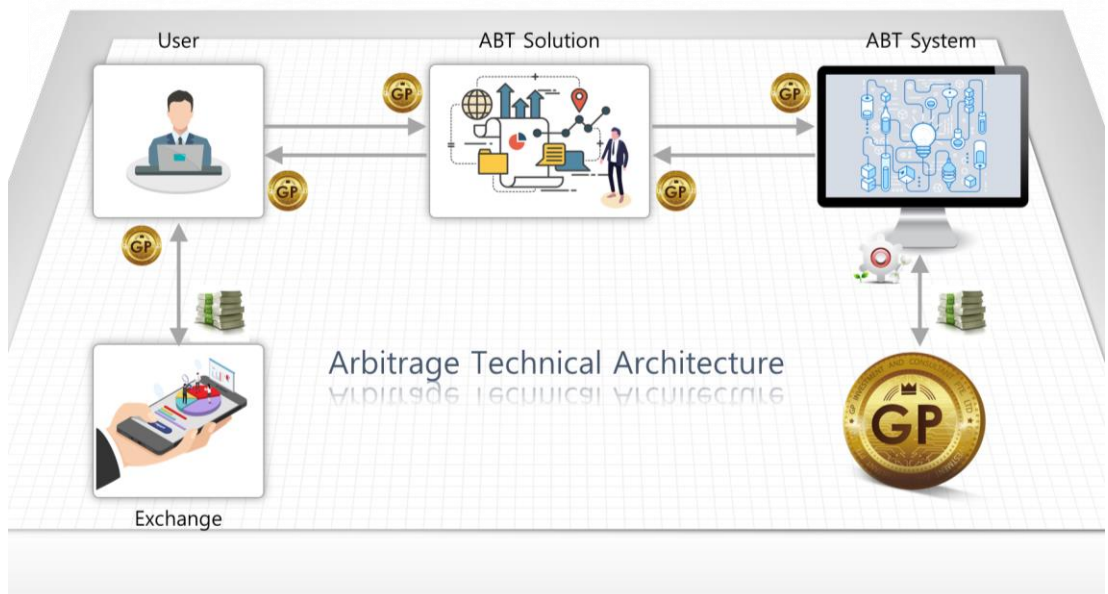
Second, the master node contributes to users completing all transactions within three seconds of real-time billing. The master node then has the authority to provide services to the system.

Third, GP Token will be issued by the organization that links the data miner with the master node. In addition, master node users will be given the right to vote on their platform to make important decisions. At this time, decentralization policy will take precedence.



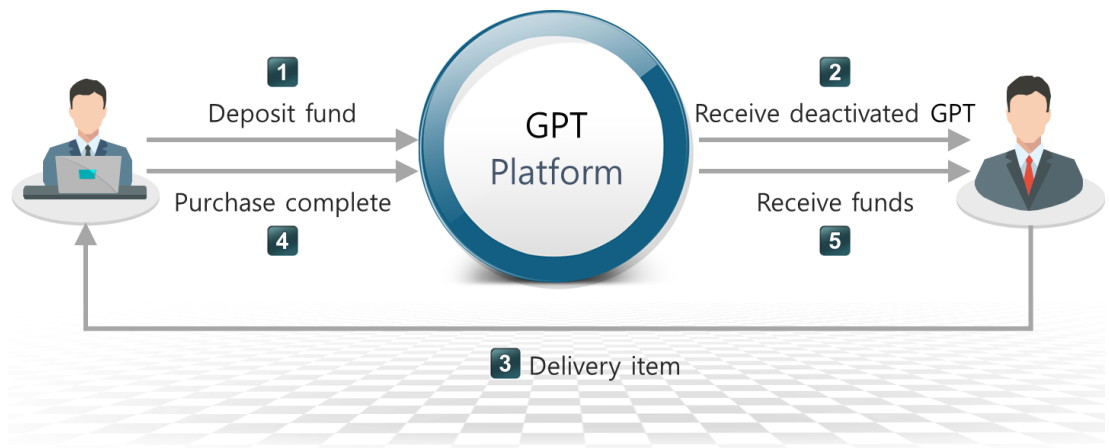
2.4 ABT Solution(Arbitrage System)

The GP Token platform provides the ABT solution (Arbitrage System). Coin trading is possible with exchange and other coins selected as cumulative data values. The ABT solution uses a robot to buy coins at the lowest price for a specified period of time and then transfers the coins to the highest exchange. As a result, users can be assured of sales profits resulting from price differences.



2.5 ESC Solution(Base On Online)

The GP Token platform provides buyers and sellers with a real-time Online-based ESC Solution. When purchasing a product, the buyer deposits his or her assets in the transaction account within the GP Token platform. At this time, the seller can guarantee the GP Token from frozen assets before sending the goods in kind. When the seller receives the item sent by the buyer, the purchase is completed and the seller receives the GP Token deposited by the buyer.



2.6 CBR Solution(Base On Offline)

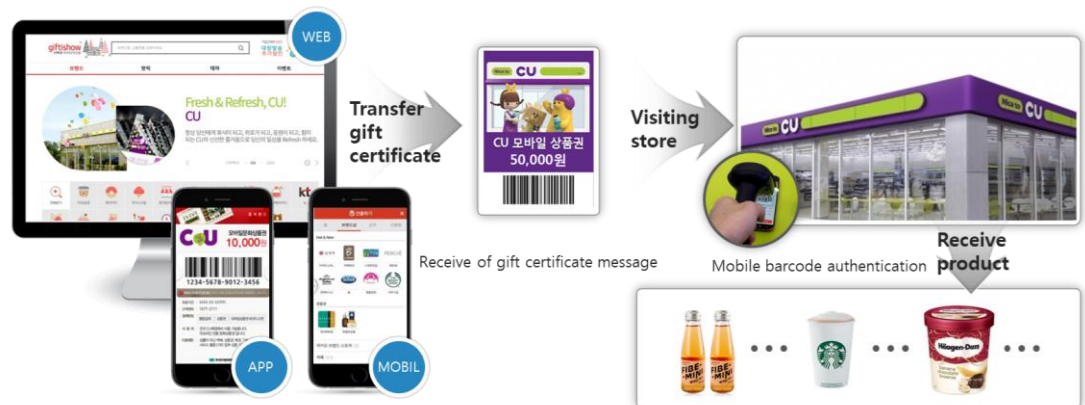
2.7 Pay Solution

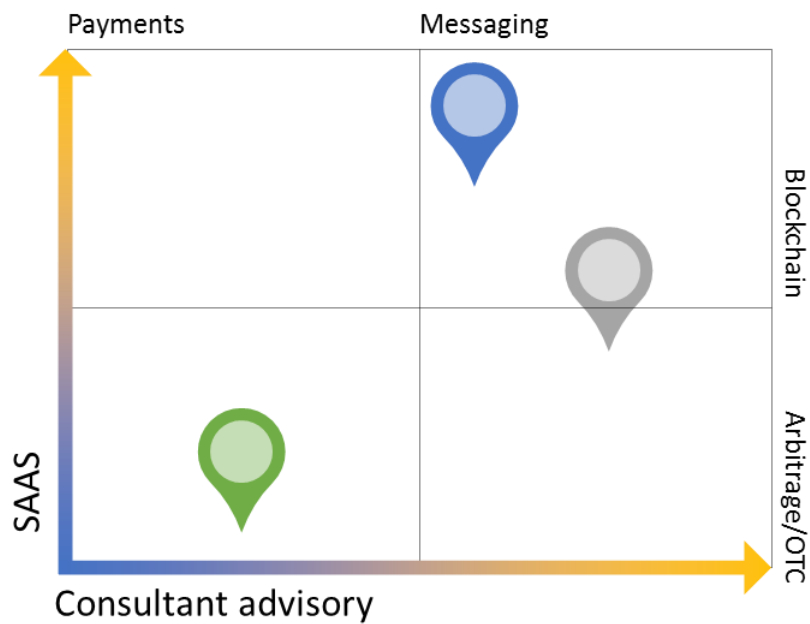


4.1 Service

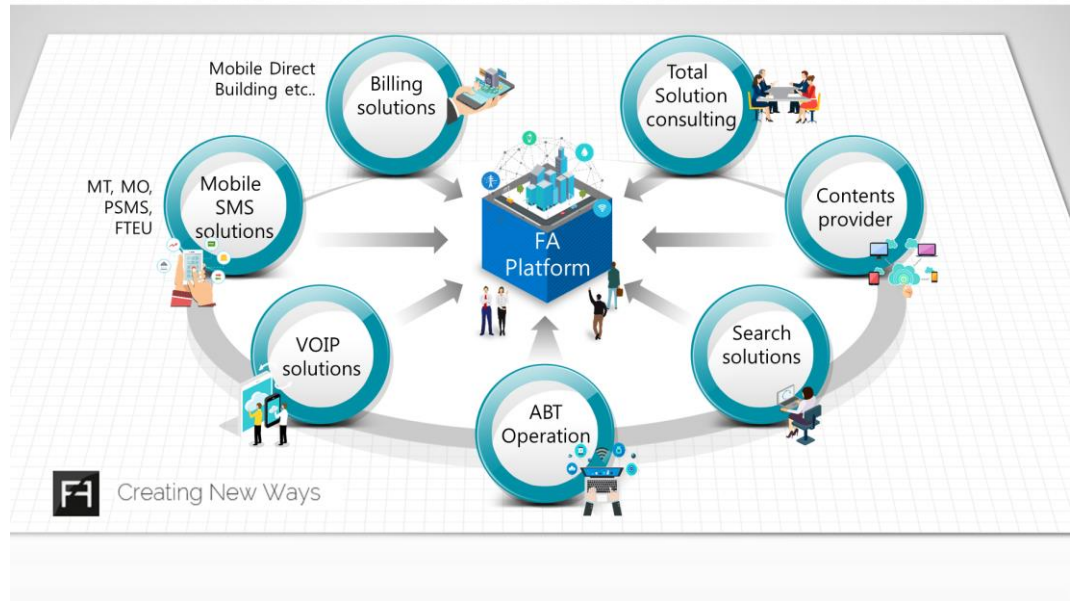
4.2 Value Realization Strategy

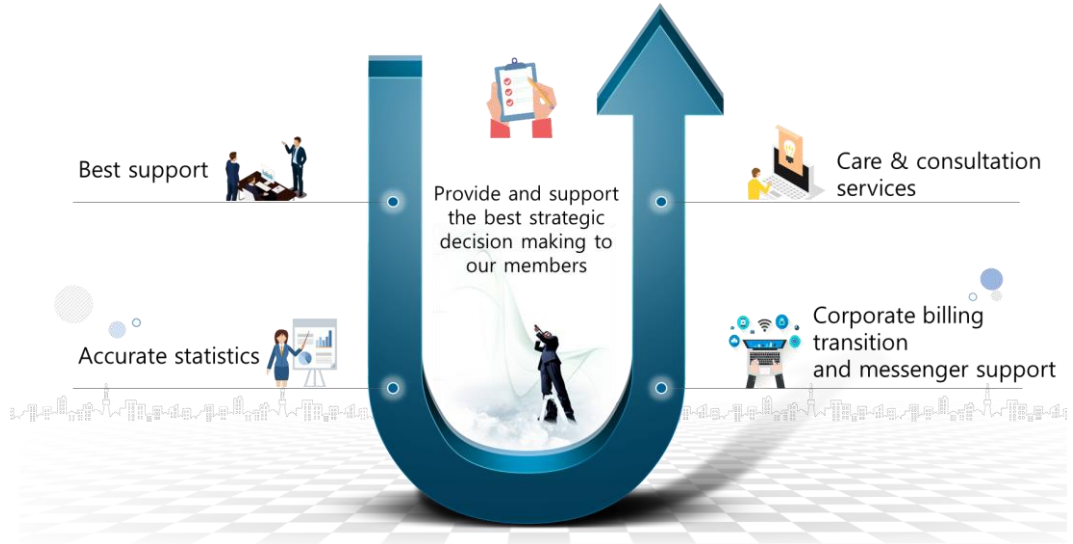

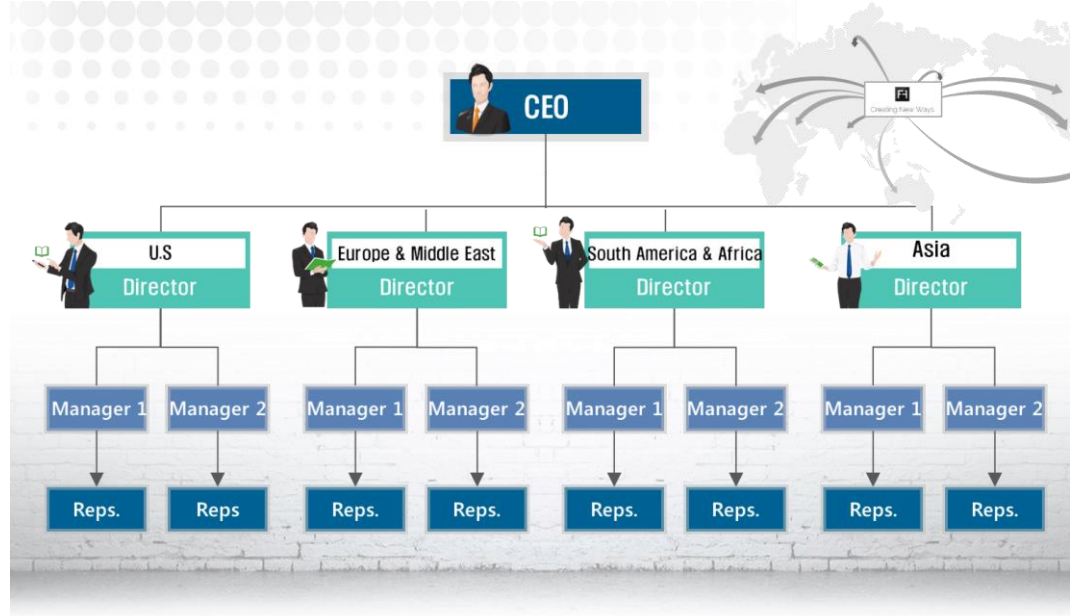
7. Roadmap
