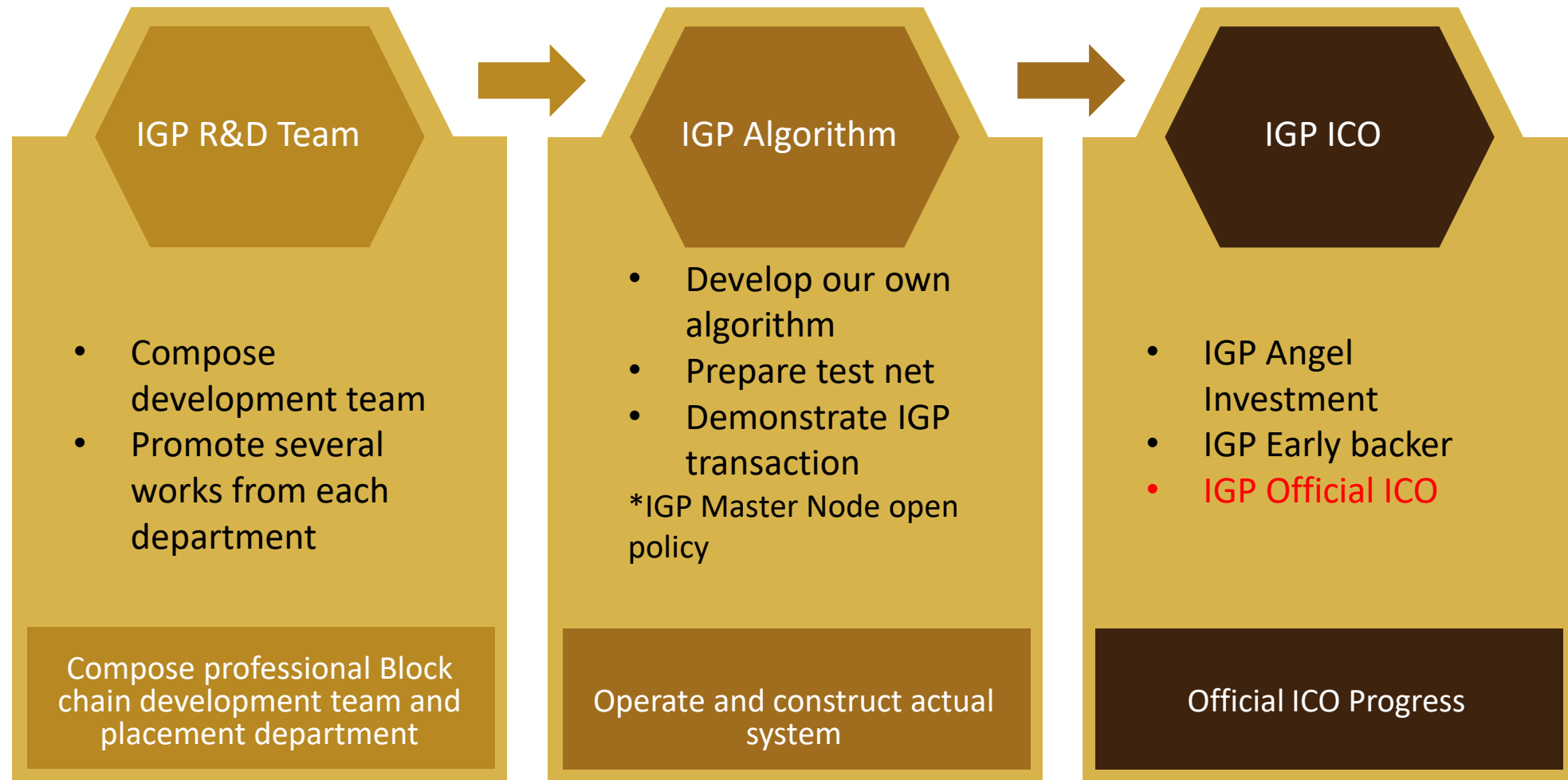


## 2.1 Platform

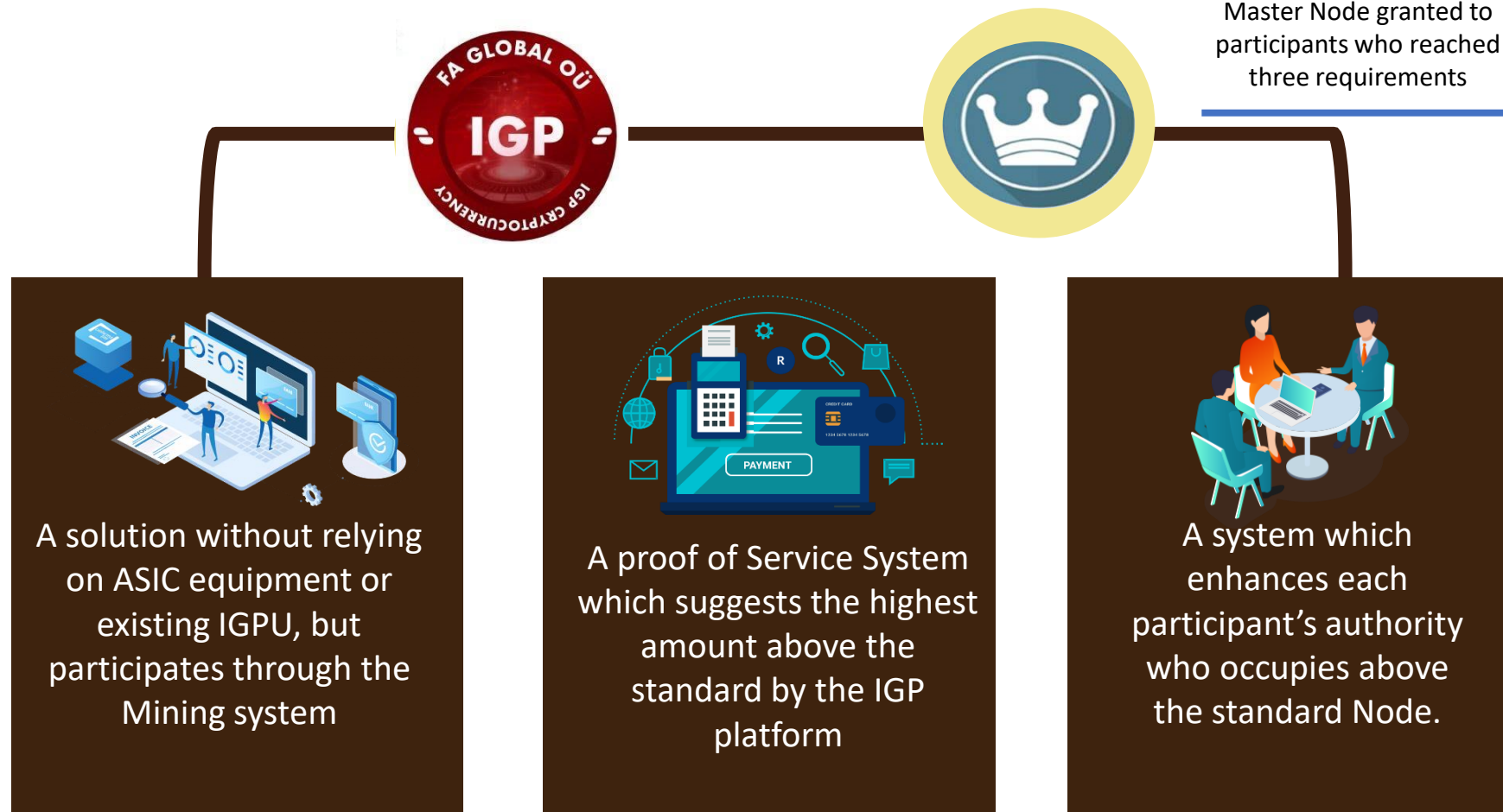
## 2.2 ICO
